Purpose

To consider and review the Audit Report of the Annual Financial Report for the year ending 30 June 2020 and address any issues presented in the report and recommend to Council any matters that require action to be taken.

Background

Following proclamation of the Local Government Amendment (Auditing) Act 2017, the Auditor General has become responsible for the annual financial report audit of the Shire of Williams.

The Auditor General contracted Butler Settineri Audit to perform the Shire of Williams annual financial report audit for the year ending 30 June 2020. The audit procedure has been conducted under the direction of the Auditor General, who retains responsibility for forming the audit opinion and issuing the Audit Report to the Shire.

Comment

On Thursday the 26 November 2020, Cr Jarrad Logie, Cr Simon Harding, Geoff McKeown and Cara Ryan attended an audit exit meeting with Suraj Karki (from the Office of the Auditor General) and Marcia Johnson (from Butler Settineri). Marcia Johnson discussed the key audit matters and audit outcomes.

Once again the Auditor's Opinion letter will report on the Operating Surplus Ratio as a significant adverse trend. It is below the Department of Local Government, Sport and Cultural Industries basic standard of 0.01, and has remained below this for the last three years. The 2019/2020 calculated Operating Surplus Ratio is (0.053).

The opinion letter also includes a finding from the interim audit about the access controls currently available to employees using the Shires accounting software. All finance employees have the ability to make modification in the system to supplier records. This is a limitation in the software to restrict some controls and an ICT Strategic Plan is currently being prepared. This will include investigation for alternative software options.

Other items discussed and contained in the Management Letters, for both the interim and final audit, that are currently being addressed are:

- 1. The Shire does not have an ICT Strategic Plan,
- 2. Purchasing Policy provides limited guidance in relation to contact variations and extensions.
- 3. The Shire has incorrectly recorded 100% of the income and expenditure of the joint venture operation of housing, instead of just recording the Shires portion.

There were no other unresolved issues or outstanding matters. The Auditor has issued an unqualified audit opinion.
